### ***New Location Confirms Whole Foods Market's Entry Into Tennessee***

**ATLANTA (May 4, 2005)** – Whole Foods Market® (NASDAQ: WFMI), the world's leading natural and organic foods supermarket, today announced plans for a new store in Nashville, Tenn., the first Whole Foods Market for the city and for the state.

With an expected opening in fall 2006, the new store will occupy approximately 48,000 square feet of retail space on Hillsboro Road at the new **Hill Center at Green Hills** development announced by H.G. Hill Realty Company in May 2004.

Whole Foods Market's presence in Tennessee further expands the company's growth in the Southern United States, joining stores already open or in development in Georgia, Alabama, North Carolina, South Carolina, Florida, Louisiana, Kentucky and Virginia.
